Objective

The fund's investment objective is to seek total return through a combination of current income and long-term capital appreciation.

Strategy

Using a combination of a top-down macro risk framework and bottom-up fundamental security analysis, the portfolio management team seeks to build a portfolio of equity securities of real estate investment trusts (REITs) and real estate-related companies across a variety of real estate sectors, regions and countries. A disciplined valuation process guides the team to invest in securities they believe can provide superior returns over the long term.

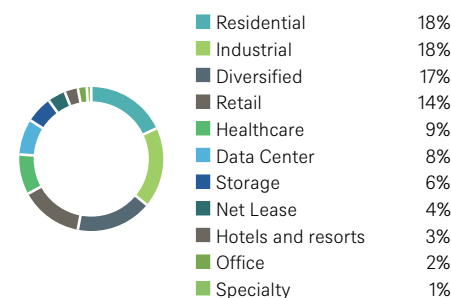

The Overall Morningstar Rating for a managed product is derived from a weighted average of the performance figures associated with its three-, five-, and 10 year (if applicable) Morningstar Rating metrics. The weights are 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods.
