The team selects stocks based on consideration of intrinsic value relative to market price and seeks to deliver high risk-adjusted returns over time. The strategy is designed to manage systematic risk in-line with the benchmark and target active risk primarily to stock selection.

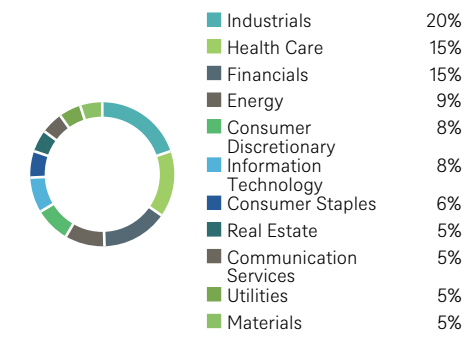

The Overall Morningstar Rating for a managed product is derived from a weighted average of the performance figures associated with its three-, five-, and 10 year (if applicable) Morningstar Rating metrics. The weights are 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods.

Average market capitalization measures the size of the companies in which the fund invests.
